California Women in Timber (CWIT) is a 501(c)(3) non-profit organization committed to sustainable forestry and natural resources management. The North Coast Chapter, based in Humboldt County, is offering scholarships to high school seniors and college students who are pursuing higher education in the 2024-2025 school year.

### **Scholarship Information:**

- Scholarships are open to all courses of study; however, special considerations will be given to students pursuing an education in natural resources-related fields, *with preference given to forestry.*
- Students with practical experience within natural resources fields are encouraged to apply.
- Scholarship amounts will range between \$1,000 and \$3,000 based on the applicant pool.

### **Minimum Qualifications:**

- You will attend college during the 2024-2025 school year.
- You currently hold a minimum cumulative GPA of 2.5.
- You meet *one* of the following requirements:
  1. You are currently attending/have attended a Humboldt or Del Norte County high school,  
OR
  2. You will be a full-time student at College of the Redwoods or California State Polytechnic University, Humboldt  
OR
  3. You will be a full-time student studying forestry or a natural resources-related field at a college or university within the state of California.

### **The following items must be included in your application packet:**

1. 2024 Scholarship Application (with Signed Statement of Integrity)
2. Cover Letter (responding to prompt provided in the Cover Letter Instructions)
3. Resume
4. Unofficial Transcript
5. At least one Letter of Recommendation (can be sent separately if necessary)
